Conditions of Sale

1. Purchaser(s) must have the Dane examined by their Veterinarian within 72 hours of leaving the Seller.
2. Purchaser understands that there are no refunds.
3. Purchaser(s) will make sure their Veterinarian is very familiar with Great Danes or the Giant breed.
4. **Limited AKC Registration:** CAN'T BE USED FOR BREEDING AT ALL. Seller requires the Dog to be spay/neutered if not done so already. Proof must be sent to the Seller a.s.a.p. in order to receive AKC paperwork. Any litters produced or sired by the Dog cannot be registered. The Dog will NOT be registered with any other Registry whatsoever besides the American Kennel Club.
5. **Full AKC Registration:** The Dog shall NOT be bred until after receiving certification or pre-certification of Hips, Elbows, Thyroid, etc. from [OFA](#), [PENNHIP](#), [CERF](#), etc. Dog shall only be bred to similar health certified & [American Kennel Club](#) (AKC), [Canadian Kennel Club](#) (CKC) and/or [Federation Cynologique Internationale](#) (FCI) Fully Registered Great Dane. Dog may be registered with the AKC, CKC and/or the FCI only.
6. The Purchaser(s) must follow the Seller's [Feeding Guidelines](#) for the life of the Dog. (see [Adult Dog Packet](#))
7. The Purchaser must give the Dane Glucosamine & Chondroitin tablets on a daily basis for the life of the Dane.
8. Under no circumstances is this Dog to be placed in a pet shop, animal shelter, rescue etc., used in Dog fighting or similar activities, tied up or left outside to live as an outdoor pet, kept in a crate or locked up for long periods of time, be abused, neglected, starved, maimed or denied veterinary care.
9. Purchaser(s) will be responsible for any falsifications on the Dog's health and registration records after the Dog leaves the Seller.
10. Dog is up-to-date on vaccinations and de-wormer. Purchaser must continue with the vaccination schedule. **One vaccination must NEVER be given within 7-10 days from any other type of vaccination.**
11. Purchaser(s) agrees to keep in contact with the Seller & provide the Seller with updated pictures of the Dog & allows the Seller to use said pictures on Seller's website. **If relocating, the Purchaser(s) must contact the Seller within 30 days or less with a new phone number, address & email address.** Seller will do the same. Seller reserves the right to contact the Purchaser(s) to inquire about the Dog.
12. The Purchaser(s) understands that in the event that he/she is unable to keep this Dog, for any reason, the Dog is to be returned into the care of the Seller, at the Purchaser(s)' expense with AKC paperwork, Medical records, etc.
13. Failure to comply with all of the above conditions of sale will result in the immediate return of the Dog to the Seller at no cost to the Seller along with all medical records, registration paperwork etc. If the Dog is returned to the Seller in any state of neglect, abuse (medical or otherwise) or is shown to be starved or maimed, the Purchaser(s) will be held liable for any & all costs the Seller will/has incurred in order to restore the Dog back to good health.

Guarantee & Exclusions

1. This guarantee follows the N.Y. State laws governing the [Sale of Dogs and Cats](#). Seller will guarantee the Dog against hereditary/congenital disease's not connected to old age for a period of 14 (fourteen) days from purchase date. If a problem arises that the Dog cannot be a suitable pet within the first 14 (fourteen) days from the date of purchase, according to a veterinarian's testing results, then the Purchaser(s) will have one of the options outlined in the N.Y. State laws governing the [Sale of Dogs and Cats](#) after the Seller receives the N.Y.S form "Veterinary Certification of Unfitness of Dog or Cat for Purchase" which is the last page of the Sale of Dogs and Cats form. If Seller has to pick up the Dog, there is a pick up fee of \$1.00 per mile round trip.
2. Under no circumstances does the Seller guarantee any preventable or accidental death, injury or illness or any problems that are not genetic or hereditary. Examples: Failure to vaccinate on schedule, allergic reaction to any vaccinations or foods, skin problems/acne, treatment against heartworm or any other parasites, Panosteitis (Pano), Osteochondritis Dessicans (OCD), failure to seek veterinarian treatment as needed, etc.
3. Seller does not guarantee Dog from illness or death caused by any surgery administered to the Dog after it leaves the Sellers.
4. Under no circumstances does the Seller guarantee any preventable or accidental death, injury or illness or any problems that are not congenital or hereditary. Examples: Failure to vaccinate on schedule, allergic reaction to any vaccinations or foods, skin problems or acne, treatment against heartworm or any other parasites, Panosteitis (Pano), Osteochondritis Dessicans (OCD), illness or death caused by any surgery administered to the Dog after the Dog leaves the Seller; Bloat nor any illness believed to be related to feeding foods not recommended by the Seller, feeding table scraps, overfeeding, overfeeding high amounts of protein, calcium, or fat, supplementation or over supplementation of vitamins & minerals (Glucosamine & Chondroitin are the only acceptable ones) and/or failure to seek veterinarian treatment as needed etc.
5. Guarantee becomes null & void & Purchaser(s) is in breach of this contract if the Dog is not current on all vaccinations as listed above, and if it is determined by a Veterinarian that the illness or death of the Dog was due to neglect or abuse in any way.

Both parties recognize Jefferson County, New York as the jurisdiction in which this contract was created, and as such, should any disputes arise as a result of this contract, which are unable to resolve amicably, agree that any court proceedings will take place in Jefferson County, New York. Purchaser(s) will pay for any and all claims by the Seller for court cost, lawyer's fees, and lost time and wages assessed in the resolution of any disputes as a result of court proceeding. This guarantee is in addition to the New York State Department of Agriculture and Market laws. The terms and conditions of this agreement have been read, understood, and agreed to in its entirety on this
