This contract is in addition to N.Y.S. Agriculture & Market Laws – [Article 35-D](#) of the General Business Law Relating to Sale of Dogs & Cats

Conditions of Sale

- 1) Purchaser(s) must have the Puppy examined by their Veterinarian within 72 hours of leaving the Seller.
- 2) \$350.00 deposit is NON-REFUNDABLE. Please make sure you have thought through your decision.
- 3) **Limited AKC Registration: CAN'T BE USED FOR BREEDING AT ALL.** Seller requires the Puppy to be spay/neutered between the ages 6–12 months. Proof must be sent to the Seller a.s.a.p. in order to receive AKC paperwork. Any litters produced or sired by the Puppy cannot be registered. The Puppy will NOT be registered with any other Registry whatsoever besides the American Kennel Club.
- 4) **Full AKC Registration:** The Puppy shall NOT be bred until after receiving certification or pre-certification of Hips, Elbows, Thyroid, etc. from [OFA](#), [PENNHIP](#), [CERF](#), etc. Puppy shall only be bred to similar health certified & [American Kennel Club](#) (AKC), [Canadian Kennel Club](#) (CKC) &/or [Federation Cynologique Internationale](#) (FCI) Fully Registered Great Dane. Puppy may be registered with the AKC, CKC &/or the FCI only.
- 5) Under no circumstances is this Puppy to be placed in a pet shop, animal shelter, rescue, used in dog fighting or similar activities, tied up outside to live as an outdoor pet, kept in a crate or locked up for long periods of time, be abused, neglected, starved, maimed, or denied veterinary care.
- 6) The Purchaser(s) understands that in the event that he/she is unable to keep this Puppy, for any reason, the Puppy is to be returned into the care of the Seller, at the Purchaser(s)' expense with AKC paperwork & Medical records.
- 7) The Purchaser(s) must follow the Seller's [Feeding Guidelines](#) for the life of the Puppy. (See [Puppy Packet](#))
- 8) The Purchaser must give the Dane Glucosamine & Chondroitin tablets on a daily basis for the life of the Dane.
- 9) Purchaser(s) will make sure their Veterinarian is very familiar with Great Danes or Giant breeds.
- 10) Puppies have age appropriate shots (DA2PPv+Cv & Kennel Cough) & de-worming, & they will be started on Heartgard Plus (or equivalent) for heartworm prevention & Advantix (or equivalent) for flea & tick prevention during warm weather months. Vaccination & de-worming schedule must be followed for the life of the Puppy/Dog. **One vaccination must NEVER be given within 7-10 days from any other type of vaccination.** (see [Puppy Packet](#))
- 11) Purchaser will provide the Puppy a cushioned/comfortable sleeping area inside the family's home.
- 12) Seller is not responsible for any bills what so ever, & will not be responsible for any falsifications on the Puppy's health & registration records after the Puppy leaves the Seller.
- 13) The Seller is not responsible for temperament issues once the Puppy leaves the Seller. It is up to the Purchaser(s) to train, discipline, & continue proper socialization of the Puppy. (Puppy /Obedience classes are highly recommended.)
- 14) Purchaser(s) agrees to keep in contact with the Seller & provide the Seller with updated pictures of the puppy & allows the Seller to use said pictures on Seller's website. **If relocating, the Purchaser(s) must contact the Seller within 30 days or less with a new phone number, address & email address.** Seller will do the same. Seller reserves the right to contact the Purchaser(s) to inquire about the Dog.
- 15) Failure to comply with all of the above conditions of sale will result in the immediate return of the Puppy/Dog to the Seller at no cost to the Seller along with all medical records, registration paperwork etc. If the Puppy is returned to the

Seller in any state of neglect, abuse (medical or otherwise) or is shown to be starved or maimed, the Purchaser(s) will be held liable for any & all costs the Seller will/has incurred in order to restore the Puppy/Dog back to good health.

Guarantee & Exclusions

- 1) The Seller will provide 24/7 guidance to the Purchaser(s) for the life of the puppy-dog.
- 2) The Seller guarantees the Puppy against hip-elbow dysplasia, congenital-hereditary problems, that would make said Puppy unsuitable as a pet up to 24 months of age. If the Puppy cannot be a suitable pet within the first 24 months of age according to a Veterinary Medicine Specialist, for example: OFA (Orthopedic Foundation for Animals), Penn Hip (University of Pennsylvania Hip Improvement Program), &/or Cornell University Veterinary Hospital, testing results, showing the Puppy has severe hip dysplasia, severe elbow dysplasia, or a life threatening congenital-hereditary condition, that would make said Puppy unsuitable as a pet for up to 24 months of age, then the Purchaser(s) may return the Puppy to the Seller at the Purchaser's expense, &/or keep the Puppy & receive a replacement Puppy of equal value once a puppy becomes available. If Seller has to pick up the Puppy-Dog, there is a pick up fee of \$1.00 per mile round trip.
- 3) If the Puppy has passed away before 24 months of age due to questionable circumstances, a necropsy must be performed at the Purchaser's expense, to indicate that the Puppy did die of a congenital-hereditary problem. If the death is found to be caused by a congenital-hereditary problem, the Seller will give the Purchaser(s) a replacement Puppy of equal value once a puppy becomes available & refund the price of the necropsy to the Purchaser(s). If the death was not from a congenital-hereditary problem neither a replacement puppy or necropsy refund will be given.
- 4) Under no circumstances does the Seller guarantee any preventable or accidental death, injury or illness or any problems that are not congenital or hereditary. Examples: Failure to vaccinate on schedule, allergic reaction to any vaccinations or foods, skin problems or acne, treatment against heartworm or any other parasites, Hypertrophic Osteodystrophy (HOD), Panosteitis (Pano), Osteochondritis Dessicans (OCD), illness or death caused by any surgery administered to the Puppy after the Puppy leaves the Seller; Bloat nor any illness or death believed to be related to feeding foods not recommended by the Seller, feeding table scraps, overfeeding, overfeeding high amounts of protein, calcium, or fat, supplementation or over supplementation of vitamins & minerals (Glucosamine & Chondroitin are the only acceptable ones) &/or failure to seek veterinarian treatment as needed etc.
- 5) Guarantee becomes null & void & Purchaser(s) is in breach of this contract if Puppy is not current on all vaccinations, & if it is determined by a Veterinarian that the illness or death of the Puppy was due to neglect or abuse in any way.

Both parties recognize Jefferson County, New York as the jurisdiction in which this contract was created, & as such, should any disputes arise as a result of this contract, which are unable to resolve amicably, agree that any court proceedings will take place in Jefferson County, New York. Purchaser(s) will pay for any & all claims by the Seller for court cost, lawyer's fees, & lost time & wages assessed in the resolution of any disputes as a result of court proceeding. This guarantee is in addition to the New York State Department of Agriculture & Market laws. The terms & conditions of this agreement have been read, understood, & agreed to in its entirety on this ____ Day of _____, 200__.
